

Plumbing World/Rheem Niue 2019 ("promotion")
TERMS & CONDITIONS OF ENTRY INTO PRIZE COMPETITION

1. **The promotion:** Subject to these terms and conditions, this promotion gives entrants who purchase an Eligible Product during the Promotional Period the chance to win one of 10 x fishing trip prizes ("competition").
2. **Promoters:** The promoters are Rheem New Zealand Limited ("Rheem") and Plumbing World ("PWL"). The decision of Rheem and PWL on all matters in connection with the promotion, including the prizes for the competition, is final and no correspondence will be entered into.
3. **Acceptance of terms and conditions:** Purchase of an eligible product during the promotional period will be deemed acceptance of these terms and conditions. Instructions on counter cards (which Rheem will provide and PWL will display during the Promotional Period) form part of these terms and conditions.
4. **Eligibility:**
 - a. The promotion is only open to qualified plumbers and gasfitters who are New Zealand residents.
 - b. The winners of the competition must:
 - i. Be over the age of 18 years.
 - ii. Have a trading account with Plumbing World and the prize will be awarded to the owner of the Plumbing World trading account.
 - iii. Be within terms of trade to be eligible to claim a prize.
5. **Promotional Period:** The "Promotional Period" is from 12.01am on 1 June 2019 to 11.59pm on 31 July 2019. An Eligible Product must be purchased within the Promotional Period to entitle an entrant to participate in the promotion. Purchases made after the end of the Promotional Period will not be eligible.
6. **Eligible Products:** An "Eligible Product" is any Rheem branded Electric Storage Low Pressure Copper/Vitreous Enamel, Mains Pressure Vitreous Enamel/Stainless Steel, Boiling & Chilled water product, Gas, Solar or Heat Pump product, or Gas Continuous Flow, Gas Storage and Rheem Commercial Products purchased during the Promotional Period. Eligible Products do **not** include Peter Cocks branded products, Rheem spare parts and accessories and/or products purchased in conjunction with any other offer (including products supplied as part of a contract or building quotation).
7. **Entry conditions:**
 - a. Subject to the additional terms and conditions in this document, to participate in the promotion, entrants must purchase an Eligible Product from Plumbing World during the Promotional Period.
 - b. PWL and Rheem take no responsibility for late purchases.
 - c. PWL and Rheem reserve the right to verify the validity of purchases.
 - d. Multiple purchases for the competition are permitted, but only one competition fishing trip prize is permitted per Eligible Product purchased.

8. **Prizes:** The fishing trip prizes are:
- a. Competition (fishing trip prizes):
 - i. An eight day fishing trip to Niue (the "Plumbing World/Rheem Niue promotion 2019") for 10 people (being the winners over the age of 18 years), with an approximate retail value of up to NZD\$6,000 per person (depending on the location of the winners and the cost of transportation). The prizes consist of:
 1. International (Niue) return flights and airport transfers.
 2. Domestic return transport, flights and airport transfers (depending on where the winners reside).
 3. Seven night's twin-share accommodation with daily breakfast.
 4. 4 x 5hr fishing charters.
 5. Island tour with Niue tourism.All other incidental or ancillary costs including additional food and beverages, mini-bar purchases, spending money and travel insurance are the winner's responsibility.
9. **Prize draw:** The winners of the competition will be drawn by PWL on or before the 14th of August 2019. The winners will be the first valid persons/businesses drawn at random from a pool of all purchasers of eligible products. The winners of the competition will be deemed to be the owner/director of the company/entity to whom the goods are invoiced and paid by. Any dispute as to the identity of the winners will be determined by PWL in their sole discretion.
10. **Notification and publication of winners:** The winners will be notified by phone during the fortnight following the draw, using the phone number provided by the winner in his/her PWL account details. If contact cannot be made with the winners during that fortnight, the prizes will be deemed forfeited and another draw held within three business days for replacement winners. By accepting or using the prizes, the winner agrees to his/her name being published on Rheem's and PWL's websites and social media channels, and the winners to be available for reasonable publicity purposes by Rheem or PWL for 12 months following notification to the winners of the outcome of the prize draws, without remuneration or compensation.
11. **Transfer:** The competition prizes are non-transferable. If you are unable to travel during the period stated (26 October to 2 November 2019) you will forfeit the prize and another winner will be drawn in the same method. Tickets are non-transferable except as set out in the ticket conditions of the airline and/or travel agency. Tickets cannot be used for commercial or promotional purposes or resold for more than their original sale price.
12. **Redemption of prizes:** The winners understand that international travel is required. All winners must be in possession of a valid passport and necessary visas or permits prior to the commencement of travel. The competition prizes must be taken on dates specified by Rheem & PWL (26 October to 2 November 2019). If the winners are unable to use the prizes on the specified dates, the prizes will be deemed forfeited. The prize cannot be exchanged, transferred or redeemed for cash.
13. **Modification, suspension or cancellation of the promotion or prizes:** If for any reason this promotion or the competition prizes (or any part of either) is not capable of being run as planned due to any cause beyond the reasonable control of Rheem & PWL, Rheem & PWL reserve the right in its sole discretion to modify, suspend or cancel the promotion or prizes (or any part).

14. **Waiver, indemnity and statement of eligibility:** It is a condition of accepting or using the competition prizes that the winners must sign a waiver and indemnity (confirming they accept the risks involved in using the prizes) and a statement of eligibility in the form determined by Rheem in its absolute discretion. The statement of eligibility will include a declaration of any health related issues which may affect their safety or ability to participate. If considered necessary by Rheem in its absolute discretion, a prior written medical clearance must be provided. Failure to sign the documentation or provide any necessary medical clearance will result in the forfeiture of the prize.
15. **Rules:** It is a condition of accepting or using the competition prizes that the winners will abide by the rules of the Niue competition, and that the winners will follow all instructions and directions from the PWL/Rheem hosts.
16. **Disclaimer:** To the maximum extent permitted by law, neither PWL, Rheem nor any person or entity associated in any way with the promotion or the competition prizes shall be liable for any loss, damage or personal injury of whatsoever nature in connection with the promotion or prizes (including, without limitation, indirect or consequential loss) and howsoever sustained, whether due to negligence or otherwise.
17. **Property and personal information:** All personal details provided by PWL account holders will be held by PWL. The details will be used for verification of the winner's identity and, unless otherwise requested, may be used for future promotional activities conducted by PWL and/or Rheem. Under the Privacy Act 1993 entrants may access and correct their personal details by contacting PWL.
18. **Changes to these terms and conditions:** Rheem New Zealand Limited may change information on the promotion or these terms and conditions at any time and without notice. Any changes will be effective immediately on publication of the revised terms and conditions.
19. **New Zealand law:** The promotion and these terms and conditions are governed by New Zealand law.
